 - Breakout Rooms
 - How significant are the economic impacts from COVID-19 & how does that impact your sustainability efforts?
 - Alelia Parentueau (City of Santa Barbara)
 - Significant impacts due to being a tourism based city
 - Budget reductions up to 10%
 - Hiring freezes and issues with workload capacity
 - Benjamin Druyon (CVAG)
 - Also a tourism based city
 - Busy with launch of CCA
 - Focus on ensuring customers are taking part in SCE's CARE and FERA programs
 - Kim Fuentes (SBCCOG)
 - For us it's been mixed some cities are moving forward with projects and some cities are heavily impacted by the economy and lack of sales tax revenue
 - There is a lot of discussion re: resiliency hubs/neighborhood centers for wildfires and there may be immediate opportunities for these as cities are going to need to change rapidly
 - We need to focus on economic development for cities
 - Lujuana Medina (County of Los Angeles)
 - Tourism is small portion of LAC but tax revenues that county received for services have significantly declined and there are major budget constraints



- Sustainability efforts were lower priority at the beginning of Covid-19 but now with the fires, the priority of sustainability is back at the forefront and there are now many opportunities
- Anthony Segura (WRCOG)
 - In general, increase in sustainability efforts region-wide
 - WRCOG is launching into a microgrid initiative with a grant we recently received
- Ben Lucha (City of Palmdale)
 - We have seen other cities experience furloughs and layoffs and are doing the best we can to protect employees and provide services
 - We are having to jump through more hoops to accomplish projects - our finance team is doing additional scrutiny to have staff justify projects
 - Have had to shift focus away from launching our CCA due to Covid-19
- Pam Bold (HSEF)
 - For LGs, the toughest thing is the distraction all other duties of Covid-19, fires, etc - there are new roles like issuing permitting for outdoor dining - so the capacity to focus on EE is more difficult
- Stephanie Cadena (GCCOG)
 - Shift in focus from EE and sustainability to pandemic recovery and community housing
- Kelly Lynn (SBCOG)
 - Cities are going through a lot taking a hit from sales tax revenue
 and it's not just energy programs its city-wide
 - Education for children is also a big issue
- Craig Perkins (TEC)
 - Santa Monica reduced city-wide workforce by 20% and about half of the sustainability team
 - Big questions loom about the next 12 months what does a return to normal look like and how long will it take?
 - What is missing is intervention by the federal government
- Denise Fairchild (ECC)
 - ECC is working with sustainability directors in about 25 cities and why energy is important
 - It is important to connect the dots between the recovery and EE
- How do you see the Advisory Committee and/or SoCalREN supporting?
 - Kim Fuentes (SBCCOG)



- Really impressed with SoCalREN and the services provided and we need to protect and ensure this basic level of support continues
- Would like to see more resources, we need more staff if we get all cities enrolled, we are going to need the resources to support
- We need to continue to come together as a group and submit applications to address the issues within our communities
- Alelia Parenteau (City of Santa Barbara)
 - The way we are approaching sustainability is holistic so we need to broaden the scope of the SoCalREN to go beyond EE to address the current needs of local governments and efficiently rebuild our communities during this time
- Lujuana Medina (County of Los Angeles)
 - We need to identify more resources and more funding beyond ratepayer funding
- Anthony Segura (WRCOG)
 - SoCalREN's regulatory updates have been very helpful so those need to continue
 - We also need to continue to provide avenues where we can learn from others who bring different expertise and perspectives
- Ben Lucha (City of Palmdale)
 - We need to keep doing what we do best!
 - We also need to continue to support and provide the technical expertise Palmdale and other agencies lack, and need
 - Staff was spread thin to begin with, and now they have so many additional duties; SoCalREN's support is incredibly instrumental right now, particularly financing support
- Pam Bold (HSEF)
 - We need capacity building some sort of climate core or AmeriCorps type support, but not intern level - it needs to be strategic and mid-level or higher support
- Craig Perkins (TEC)
 - The CPUC has acknowledged some of these challenges and has done a good job at softening the impacts by directing program administrators to be innovative
- Denise Fairchild (ECC)
 - There are also basic needs from a workforce perspective to think about, such as access to computers and internet

 - Christopher Moore (CPUC) volunteered to join the Resiliency Working Group
 - SoCalREN to add Christopher Moore (CPUC) to future Resiliency Working Group meeting invites (ACTION ITEM)
- Regulatory Updates (Marc Costa, TEC)
 - Covid-19 Ruling
 - Provides reasonable latitude in Sept ABALs
 - Reassurance on evaluation of program goals and metrics
 - Ruling is effective through 2022 ABAL filings



- All program administrators shall file new energy efficiency portfolios by Sept 1, 2021
- Microgrid Proceeding
 - The CPUC issued a Decision on June 17, 2020 that puts an enormous amount of responsibility in the hands of Local Governments to take charge of activities that mitigate and adapt to Public Safety Power Shutoffs
 - An even larger onus is meticulously laid out by the CPUC to ensure that the IOUs comply with the orders in the decision
 - Local governments need to diligently follow and in some cases lead these activities
 - Solar and Storage Net Energy Metering (NEM) tariffs will be more favorable with streamlined templates for interconnection in the next month
 - Public Safety Power Shutoffs (PSPS) events are ordered to be coordinated more closely with LGs
 - Battery Electric Energy Storage systems can charge from the grid for PSPS purposes under new a new net metering tariff
 - LGs are ordered to be immediately and thoroughly engaged by IOUs on resilience planning
 - A series of engagement guides, bi-annual workshops and County moderated meetings will be taking place this summer, before PSPS events are likely to occur
 - LGs will have dedicated access and trainings on a data portal for their respective IOUs that help them plan for resilience projects and general disaster planning
 - IOUs will form and dedicate teams to LGs to develop and prepare for resilience projects
 - LGs will need to participate (and in some cases moderate) these meetings and provide feedback on the IOU plans related to all the bullet points above
 - IOUs outside of SoCalREN service area have additional requirements and authorizations to launch pilot programs related to resilience and PSPS events
