- Laurel: What is your top suggestion for local governments and nonprofits to best prepare for these solicitations?
  - Attend the scoping workshops -- those will give you a leg up! We have also found that projects that are most successful are those that have a local government champion involved as a project partner, we also require CBOs to be a project partner if the project is located within a DAC. So overall, strategic partnerships are also key. For technology partners, look at empowerinnovation. Note we are also developing another source of project partners for past partners which will complement the empowerinnovation.
- Garrett Wong, County of Santa Barbara: Can EPIC include retrofits rather than new construction?
  - Yes!
- Antonia Graham, OCPA: Can CCAs apply for the EIC program?
  - Yes! And CCAs have been tremendous partners on past projects.

- Working Group Updates
  - Resiliency Working Group
    - Actively tracking the Microgrid Proceeding
    - Restarting regular calls this month
    - Focus on Microgrid Incentive Program (MIP)
      - 10 projects targeted for SCE territory
    - SoCalREN will participate in Public Meetings to help structure the program and advocate for SoCalREN public agencies
  - MIP Background and Timeline
    - D.21-01-018 approved \$200 million statewide for MIP
      - 10 microgrid projects per electric IOU territory
      - \$15m per project cap
      - Single customer projects are <u>excluded</u>
        - "This program is intended for projects that are more complex



with longer islanding duration for multiple customers as well as being targeted toward addressing the needs of vulnerable communities."

- Program Design and Implementation details not yet developed or approved
  - Stakeholder workshop needed first per <u>AL 6098-E-A</u>
  - Joint IOU Implementation Plan due October 4th, 2021
  - Project commercial operational deadline within 24 months of CPUC adoption of Implementation Plan

  - Laying the foundation (7/7)
    - Discussed objectives and what should guide development of MIP and effective community engagement.
  - Program Design (7/14)
    - Will discuss program structure needed to optimally meet goals and objectives
