

### **Legislative Calendar, 2026:**

- Jan 5—Legislature reconvenes
- Jan 10—Governor introduces budget
- Feb 20—Last day for bills to be introduced
- June 15—Budget Bill must be passed
- August 31—Last day for each house to pass bills
- Sept 30—Last day for Governor to sign or veto bills



### Recap Energy Bills This Year:

**AB 1207 -** Extends Cap and Invest (trade) through 2045.

AB 825 - Creates a regional Western energy trading market.

SB 254 - Replenishes the state's wildfire fund for utilities and make changes to how utilities finance transmission and wildfire prevention.

- \$18 billion replenishment, to be shared equally between utility customers and shareholders.
- Prevents IOUs from earning a rate of return on the first \$6 billion they spend on wildfire prevention upgrades.
- Bolsters requirements for IOUs to seek the most cost-effective ways to avoid sparking wildfires.
- Creates low-interest state loans to cover the construction of new transmission lines.

### AB 39 (Zbur)-Local Electrification Planning Act

Requires cities and counties to develop comprehensive local electrification plans that expand electric vehicle (EV) charging infrastructure and decarbonize homes and buildings—prioritizing low-income families and small businesses.

### Legislative Goals for 2026

#### **Energy Efficiency**

- Legislation that reduces utility ratepayer costs without targeting energy efficiency funding.
- Rate structure that reduces costs for buildings that use energy efficient equipment, such as heat pumps.

#### **Data Centers**

- Require Data Center energy load to be self-generated or financially subsidized by the company if increased transmission/ distribution is needed so as not to increase rates for consumers.
- Require data centers to offset their burden on ratepayers by subsidizing energy efficiency programming.

# Regulatory Updates

### SDG&E Application to Withdraw

#### What is SDG&E Requesting?

- SDG&E is requesting to cease its role as an EE Program Administrator and close its own regional EE programs, reducing its budget by \$300 million.
- It requests that associated **funding be redirected** to support existing statewide EE programs and the San Diego Regional Energy Network (SDREN).
- SDG&E wishes to transition to a "**fiscal agent**" for statewide programs, relinquishing all regional program design and management duties to other entities (e.g., SDREN).

#### What is SDG&E's Rationale for Withdrawal?

- SDG&E argues in its Application that state law does not require the utility to *administer* programs—only to *procure* EE savings.
- They argue the current landscape is too crowded with programs that are often not cost-effective or lack efficiencies.
- The application states that reducing the EE budget will achieve bill savings for customers (ranging from ~\$1.50/yr for residential customers to ~\$750/yr for large C&I).

### Recent ALJ Actions

- The initial Ruling and Scoping Memo issued in August recognized the precedent-setting nature of SDG&E's request and set a two-phase process to review the application, with an interim Legal Decision first.
- On November 3, ALJs Fitch and Kao issued a Ruling Amending Schedule, significantly changing the procedural plan laid out in the original August 8 Scoping Memo.
- The process will now be consolidated into a single phase, with parties providing testimony on policy and factual issues prior to the development of a comprehensive proposed decision.

# **Proposed Community-Based** Design Collaborative (CBDC)













### **Framework Direction**

"Because of their nature of being more locally-focused, we expect that RENs are uniquely positioned to make progress on this issue. Therefore, we will direct one of our original RENs, SoCalREN, to establish a Community-Based Design Collaborative (Collaborative) to recommend, via a Tier 2 advice letter, a process for funding community programs and to pilot the approach in 2026 and 2027 for potential rollout in the future as a statewide initiative."

### **Initiative Direction**

"SoCalREN should plan to launch a community-designed pilot program by the end of 2025 for implementation in 2026 and 2027, using an additional \$1.5 million that we will add in this decision to SoCalREN's proposed budget, in the market support segment. SoCalREN shall submit, using the existing process for program changes, a Tier 2 advice letter for the community-designed programs selected for funding through the pilot."

### SoCalREN Alignment with the Collaborative



SoCalREN is developing an opportunity to make the transition to a clean energy future a more collaborative process!

#### **Problem statement:**

Historically, energy programs have been designed with limited customization, often overlooking the unique needs of California's diverse regions.

#### End goal:

Develop more impactful programs that directly reflect and address the priorities of communities, shaped by community input and lived experience.

# **Program Overview**

CBDC offers an equity-centered engagement process to support community based organizations in developing initiatives aligned with local priorities within CPUC funding boundaries.

### Collaborative Initiative Objectives


**Our goal:** a consistent framework for evaluating proposed initiatives and ensuring that funded programs advance equity, accessibility, and measurable community benefits across SoCalREN's territory.

#### **Objectives:**

- Increase accessibility of program services
- Deliver equitable benefits to priority populations
- Support youth engagement and workforce development
- Conduct intentional and targeted outreach
- Achieve energy and bill savings where applicable
- Improve awareness and adoption of energy-efficient technologies
- Facilitate weatherization and home efficiency improvements

# Key Milestones of the Collaborative

SoCalREN developed a framework to work with community based organizations to identify and fund locally-focused energy program initiatives.



### **Initiative Application Process**

#### **Application requirements**

- Activities, goals, and barriers addressed
- Geographic area and target customers
- Organization experience implementing programs
- Proposed methodology for tracking impacts
- Budget breakdown

Facilitators offered feedback to strengthen applications and worked to reduce administrative barriers in the process.

# **Proposed Tribal Community** Resiliency Program (TCRP)















### Tribal Community Resiliency Program (TCRP)

SoCalREN's Tribal Community Resiliency Program will be filed in a Tier 2 Advice Letter asking to authorize \$1.5M of existing funding.

TCRP offers a flexible engagement process to support Tribes in developing initiatives aligned with local priorities within CPUC funding boundaries.

#### The process includes:

- Collaborative planning
- Capacity building
- Tailored initiatives



# Tribal Community Resiliency Program (TCRP) Framework Overview

- The TCRP framework is structured around five engagement meetings to support understanding of energy gaps and priorities and assistance in developing initiatives for funding.
- Each meeting is paired with a **stipend** to support staff participation and ensure equitable engagement.
- Between meetings, SoCalREN staff and partners will provide technical assistance and one-on-one support.

The five meetings are anticipated to take place over a **3-6 month** period, with flexibility based on each tribe's capacity and readiness.

### Implementation Support Options

**Option 1:** Tribal-Led Implementation: Tribes implement the initiative with their internal staff or communities, supported by SoCalREN technical assistance.

**Option 2:** SoCalREN-implemented Project: SoCalREN manages and executes the project on behalf of the tribe, in full coordination with designated tribal representatives.

**Implementation Support:** Regardless of which option is chosen, SoCalREN will provide:

- A dedicated project manager
- Technical support
- Regular progress
- Documentation of outcomes and lessons learned

#### Overview of Roles

#### **Bishop Paiute Tribe/HSEF**

- Confirm participation and designate a representative to attend remaining meetings
- Provide insights and expertise to guide decision-making and strategy
- Participate approximately Q4, 2025 through Q2, 2026
- Support gathering community feedback through surveys or in-person sessions

#### SoCalREN/HSEF

- Facilitate conversations guided through the Framework with flexibility
- Provide content on energy efficiency, program opportunities, and parameters
- Support developing initiative proposals and applications
- Communicate and assist each step of the way

## SoCalREN Dedicated Support

Regardless of which initiative implementation option is chosen, SoCalREN will provide:

- A dedicated project manager to serve as the tribe's main point of contact.
- Technical support throughout the project lifecycle.
- Regular progress updates, milestone tracking, and opportunities for feedback.
- Documentation of outcomes and lessons learned to inform future tribal initiatives.

### Overview of SoCalREN's Policy Recommendations

Focus Area	SoCalREN's Recommendation			
Portfolio Based				
REN Accountability Metrics	Revise REN Accountability Metrics to include a Non-Energy Benefit (NEB) metric that quantifies jobs, bill savings, equity, etc. (e.g., Total Community Benefit).			
Programmatic				
Fuel Switching	Create CPUC guidance/process for fuel switching to enable electrification in propane-reliant rural areas.			
Generators	Incentivize Generators (EE funds/electrification) limited to rural and tribal locations for resilience.			
NTG Values	Revise NTG values for Public Sector projects to address current low rates and reduce project barriers.			
Remediations	Allow minor remediations (structural, mold) as Market Support to remove participation barriers			
<b>Battery Storage</b>	Incentivize as a TSB+ EE measure justified by load shifting and peak demand reduction.			
Reporting/Claims				
Electrification TSB	Implement an Admin Adder and remove associated costs to boost TSB for electrification projects.			
Fuel Costs	Use CEC forecasts instead of IOU projections for fuel costs to align with state-level data.			
CPUC Processes	Increased expediency and transparency regarding custom projects, measure package updates, etc.

### Timeline (Details)

Date	Activity	Details
Ongoing	Program Feedback	Provide feedback on regional needs to SoCalREN staff to inform program design updates.
March 2026	Filing of the 2028–2031 EE Portfolio	SoCalREN files the Business Plan for the second 4-year funding phase. This is a high-impact opportunity to shape goals and strategies for 2028 and beyond.
April 2026	Protests and Responses	Stakeholders (e.g., Public Advocates Office, TURN) file formal Protests challenging specific parts of the plan.
Summer 2026	Scoping Memo	CPUC releases a memo deciding which issues are "in scope" and the official schedule.
Late 2026	Intervenor and Rebuttal Testimony	Opposing parties submit detailed testimony arguing for cuts or changes. SoCalREN submits Rebuttal Testimony to counter their arguments with data/evidence.
Spring 2027	Proposed Decision	The Administrative Law Judge releases a draft decision. Final chance to submit comments supporting SoCalREN before the vote.
June 2027	Final Decision	CPUC Commissioners vote to approve the budget and portfolio. This sets the official rules for the 2028–2031 cycle.
January 2028	New Portfolio Launch	The 2028–2031 programs officially begin implementation.


